**4. FIRST AID MEASURES**

- Skin contact : Take off contaminated clothing and shoes immediately. Wash off immediately with soap and plenty of water. In the case of skin irritation or allergic reactions see a physician. Wash contaminated clothing before re-use.
- Eye contact : Hold eye open and rinse slowly and gently with water for 15-20 minutes. If eye irritation persists, consult a specialist.
- Ingestion : Obtain medical attention. DO NOT induce vomiting unless directed to do so by a physician or poison control center. If victim is conscious: Rinse mouth with water.

**5. FIRE-FIGHTING MEASURES**

**6. ACCIDENTAL RELEASE MEASURES**

- Environmental precautions : Prevent further leakage or spillage if safe to do so. Use appropriate container to avoid environmental contamination. **7. HANDLING AND STORAGE****Handling**

- Advice on safe handling : Use only according to our recommendations. Use only clean equipment. Avoid contact with skin, eyes and clothing. Do not breathe dust or spray mist. Wear personal protective equipment. For personal protection see section 8. Prepare the working solution as given on the label(s) and/or the user instructions.
