4. FIRST AID MEASURES

5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media : Water spray, Foam, Dry chemical, Carbon dioxide (CO₂),
- Extinguishing media which shall not be used for safety reasons : High volume water jet, (contamination risk),
- Specific hazards during fire fighting : Hazardous decomposition products formed under fire conditions. Carbon dioxide (CO₂) nitrogen oxides (NO_x)

6. ACCIDENTAL RELEASE MEASURES

- Personal precautions : Evacuate personnel to safe areas. Control access to area. Use personal protective equipment. Refer to protective measures listed in sections 7 and 8.
- Environmental precautions : Use appropriate container to avoid environmental contamination. Prevent further leakage or spillage if safe to do so. Do not flush into surface water or sanitary sewer system. Do not allow material to contaminate ground water system. Local authorities should be advised if significant spillages cannot be contained. If the spill area is porous, the contaminated material must be collected for subsequent treatment or disposal. If the product contaminates rivers and lakes or drains inform respective authorities.

7. HANDLING AND STORAGE**Handling**

Advice on safe handling : Use only according to our recommendations. Use only clean equipment. Avoid contact with skin, eyes and clothing. Do not breathe dust or spray mist. Wear personal protective equipment. For personal protection see section 8. Prepare the working solution as given on the label(s) and/or the user instructions. Use prepared working solution as soon as possible - Do not store. Provide appropriate exhaust ventilation at places where dust is formed.
